In March, you made it possible for us to push for — and achieve! — unprecedented renewable electricity investments in federal Budget 2023, a historic first. Thanks to you, we've also campaigned against taxpayer-funded handouts for the oil and gas industry and, in July, Canada committed to phasing out inefficient federal fossil fuel subsidies and said it will develop a plan by 2024 for phasing out all public financing. With your support, our team attended the United Nations Biodiversity Conference COP15 in Montreal last December and worked with other organizations to help achieve the Kunming-Montreal Global Biodiversity Framework — a historic commitment to protect nature. # **INSPIRING CLIMATE HOPE**

Hundreds of thousands protested in more than 500 cities in 65 countries.



You made it possible for us to promote the youth-led Global Fight to End Fossil Fuels everywhere on the planet. People of all ages mobilized for a fast, just and equitable end to fossil fuels. That includes no new fossil fuels; new commitments for international cooperation; an end to greenwashing; holding polluters responsible for the damage they're causing; and preventing fossil fuel corporations from dictating climate action rules, financing or participating in climate talks, or sabotaging the world's response to climate change.

David Suzuki stirred Victoria attendees with his impassioned, powerful words, as did executive director Severn Cullis-Suzuki and public engagement and mobilization lead Janelle Lapointe in Vancouver with theirs.

# STOPPING CLIMATE-ALTERING GOVERNMENT SUBSIDIES

You made it possible for us to campaign against taxpayer handouts to fossil fuel companies. In July, government finally announced it would turn off that federal funding tap — an important, long-overdue step toward aligning public investments with Canada's climate commitments.

For too long, the oil, gas and coal industry — already raking in unprecedented profits and driving up inflation — has helped inflame climate chaos and delay the necessary transition to renewable energy.

But loopholes mean the public purse will still have to foot the bill for the fossil fuel industry to "clean up its act," using expensive, time-wasting, often unproven emissions reduction technologies such as carbon capture and storage — ultimately leading to *more oil extraction and increased pollution*!

The world's largest protected Greenbelt encompasses forests, wetlands, rivers, lakes and some of the best agricultural land in Canada. Since March 2021, you've fuelled our campaign to stop Highway 413 and safeguard the Greenbelt. # SUPPORTING INDIGENOUS LAND AND WATER DEFENDERS

"The only people with a track record of living sustainably in place for thousands of years are Indigenous people, and despite all that has been done to get them out of the way, they are still here fighting for their land."

When settlers arrived in what is now called Canada, they initially made treaties with Indigenous Peoples in some territories to share the land. These guaranteed that Indigenous communities would still be able to carry out their traditional ways of life. But Canada's implementation of treaties has, in almost every instance, failed to honour that understanding.

In other territories, treaties were not signed. Indigenous Peoples made no legal agreements with Canada to share responsibility for the lands and waters, and Canada took over governance without consent.

Because most people are unaware of this political landscape, with your help, we created *Treaty Promises*, a five-part video series that examines the relationship between Canadian citizens, Indigenous Peoples and treaties.
